- a. <u>Building Manager Report:</u> Linda Fyfe, Manager's Report dated 6/15/21, New classes have been added. Power Clean will come and clean the cooking hood the cost quote is \$775.00 the hood had not been cleaned in 5 years
- b. Master Plan/Ground Maintenance: Maintenance Contract Option 2, \$,1350.00 plus tax per month, 1 time strip clean up: \$485.00 plus tax and material; need for irrigation repair \$165.00 plus tax. - e. <u>Village Green Foundation Update:</u> Keith Beebe, Liberty Bay Bank Loan principal payment was paid \$3,000.00 at the end of May. The Liberty Bay Loan Balance is aprox. \$79,000.00. Virtual Breakfast net is approx. 3K. Music on the Green is planned for Aug and Sept. Art Summer Gallery in July, Opera in Dec & some version of Pie in the Park is planned for Aug 12th 2021. All outdoor activities are on hold on hold until the Governor's Orders are lifted/modified but planning is still on-going. In addition, fundraising will continue.
